Violations Comments

Violation #48. Ware washing: installed, maintained, & used; test strips

Provide unexpired test kit to accurately measure the sanitizing solution concentration. Observed facility had one test kit to measure the sanitizing solution concentration; the test kit had expiration date of 07/01/22.

CODE REFERENCE: 64E-11.003(4). Warewashing facilities must be approved, available, maintained, effective, and used for cleaning and sanitizing food-contact surfaces and equipment. Test strips are available and used to verify the solution is at a concentration necessary to achieve sanitization.

Violation #53. Toilet facilities: supplied, & cleaned

Eliminate biological growth at employee restroom ceiling (room#302A). Observed with dark black discoloration. Use other employee restroom until issue is resolved.

CODE REFERENCE: 64E-11.003(5). Toilet facilities shall meet applicable plumbing code, be kept clean, provided with toilet paper and covered waste receptacle, and utilize self-closing doors.

Violation #55. Facilities installed, maintained, & clean

Replace water-stained ceiling tile inside the laundry/employee restroom area. [This is a repeat violation from last routine inspection 05/20/22]

Replace water-stained ceiling tile by walk-in cooler (above drinking fountain) and by 3-compartment sink area.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
