Violation #55. Facilities installed, maintained, & clean

Observed A/C wall inside dry food storage room #321 bare, in need of paint. Complete wall work order.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.

Violation #56. Ventilation & lighting

-Observed 1 (one) burned-out ceiling light inside dry storage room#321. Per PIC, work order in place. Replace.

-Observed burned-out light inside 2-door Continental freezer, TAG#1011135. Per PIC, work order in place. Replace.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
